Mayor Hanics called the Meeting of the Common Council of the Borough of Alpha to order at

7:00 p.m. on Tuesday, April 22, 2014

Mayor Hanics announced that adequate notice of the meeting was given to the Express-Times and posted on the bulletin board in the Clerk's office satisfying the requirements of the Open Public Meeting Act:

NOTICE

Pursuant to the provisions of the Open Public Meetings Act, adequate notice of this meeting has been given. On January 3, 2013, the Municipal Clerk delivered to The Express-Times and posted on the bulletin board in the Municipal Building, a notice containing the date, time and place of this meeting of the Alpha Borough Council. Also, said notice has been mailed to persons requesting the same.

Mayor Hanics led prayer and the salute to the flag.

Roll Call: Present: Councilman Cartabona, Councilman Rooks, Councilwoman C. Schwar, Councilman M. Schwar (*entered at 7:14pm*), and Councilman Seiss. Also present Administrative Clerk, Christy Rose, CFO, Lorraine Rossetti and Attorney Christopher Troxell. Absent: Councilman Zikas.

Public Comment

Craig Dunwell, from 1159 Seventh Avenue, pointed out resolutions listed on the agenda approving projects for which the funding is not available. For this reason, Mr. Dunwell suggested the resolutions be tabled. Lengthy discussions followed regarding the urgency and funding of the projects and it was decided the resolutions would be tabled following their presentation for approval.

Tracy Grossman, from 833 Seventh Avenue, presented a business plan for the pool and expressed her hopes for feedback from Mayor & Council in addition to the scheduling of a second meeting soon.

John Lacaruba, from 1805 Springtown Road, asked for an update regarding remediation for the flooding still occurring on his property. The Engineer addressed Mr. Lacaruba's question followed by lengthy discussions regarding flooding issues and potential solutions.

Craig Dunwell, from 1159 Seventh Avenue, appealed to Mayor and Council to make a decision to do the right thing, spend the necessary money, and fix the issue of the flooding for the few residents who have been affected negatively for the benefit of many.

Tracy Grossman, from 833 Seventh Avenue, asked for any information available about the sharing of the Alpha court with Phillipsburg. Attorney Troxell responded the issue is not allowed to be discussed in public at this time.

Craig Dunwell, from 1159 Seventh Avenue, discussed the shared court services agreement with Phillipsburg as he feels the agreement is deficient because it doesn't anticipate how increased ticket volume is proportioned against what borough pays them to do their court. He continued that they should be compensated for additional work only, using a sliding scale to cover additional costs.

Michael Savary, from 1210 Park Avenue, inquired about the invoice for Enviroprobe on the bill list with regards to the location of the work (Schley Avenue). Mr. Savary indicated that he looked at the park and wondered if cleaning up branches at the park is included in the lawn maintenance contract. Councilwoman C. Schwar responded that she was told this was done. Mr. Savary asked how long the Borough has been paying an employee when he goes on fire calls and if this is a correct procedure, stating he would not have an issue with it if the employee was responding for Alpha's fire company, but this is not the case. Attorney Troxell stated it is a personnel issue and advised no one should comment and indicated that public comment is not for asking questions. Councilman Cartabona stated that he loves hearing comments and encouraged them because they are a great reminder to Mayor and Council of issues they need to work on.

Chuck Bodogh, from 117 East Central Avenue asked about matted grass, leaves and other debris left behind in the yards after repaving at 714 Seventh Avenue. Mr. Bodogh asked when they are going to come back to fix it as they had beautiful lawn before they did the project and also wondered why they didn't they just hydro-seed instead of wasting straw. Discussions ensued regarding debris left from paving projects in the Borough and Mr. Bodogh asked if there any way to temporarily put a 10 mile per hour speed limit in the work area to avoid the dust issues during the project.

Mr. Dech, from 611 Vulcanite Avenue, suggested parking on one side (of Vulcanite Avenue) as it is too narrow.

Lloyd Best, from 1000 Dewey Avenue, had a lot of macadam on his property from the snow plowing and asked if he could drop it off at grass clippings area. Pete Pursel, from the DPW, stated he will pick it up as they take a pile they have to Warren Paving. Discussion continued regarding the chipping schedule (1st & 3rd Thursday of each month), the sizes of branches and weeds allowed to be put out for chipping, and Mayor & Council advised the public to let the branches be picked up as opposed to bringing them to the grass clipping site. The current yard waste recycling site hours (Saturdays 10am-4pm) were discussed as well as additional hours being added starting in May.

Charles Bodogh, from 117 West Central Avenue discussed his concerns regarding the straw in the Borough not being cut down or something holding it into place.

Ordinance-First Reading: None.

Councilwoman C. Schwar made a motion to open the public hearing for the second reading of Ordinance #2014-07, Councilman Rooks seconded. Councilman Cartabona voiced his objection to the ordinance due to his concerns regarding increased ability to spend on certain line items growing yearly. Roll Call; Ayes: Councilwoman C. Schwar, Councilman M. Schwar, Councilman Rooks, and Councilman Seiss. Nays: Councilman Cartabona. Absent: Councilman Zikas.

ORDINANCE 2014-07 "CAP" ORDINANCE TO EXCEED INDEX RATE FOR THE YEAR 2014 (N.J.S.A. 40A:4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.40A:4-45.1 *et seq.*, provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.0% or the Cost of Living Increase (COLA), whichever is less, over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, P.L. 1986, C.203 amended the Local Government Cap Law, to provide that a municipality may, in any year in which the index rate is less than 2.0%, increase its final appropriations by a percentage rate greater than the index rate but not to exceed the 3.5% rate as specified in the law, when authorized by ordinance, and

WHEREAS, the COLA rate for 2014 has been certified by the Director of the Division of Local Government Services in the Department of Community Affairs as 2.0%; and

WHEREAS, the Borough Council of the Borough of Alpha in the County of Warren finds it advisable and necessary to increase its budget by more than 2.0% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and

WHEREAS, the Borough Council hereby determines that a 3.5% increase in the budget for said year, amounting to \$47,876.36 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary.

WHEREAS, the Borough Council hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Borough Council of the Borough of Alpha, in the County of Warren, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the 2014 budget year, the final appropriations of the Borough of Alpha shall, in accordance with this ordinance and P.L. 1986, C.203, and be increased by 3.5%, amounting to \$47,876.36 and that the 2014 municipal budget for the Borough of Alpha be approved and adopted in accordance with this ordinance; and

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the

Director of the Division of Local Government Services within 5 days of introduction; and

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Departmental Reports:

Administration, Councilman Harry Zikas: Absent. No report.

Councilman Seiss approved bills salaries and wages for this department.

Finance, Councilman Michael Schwar: Councilman Schwar reported the Borough received the Houston-Galveston application and that it will take few weeks to process before we can get a quote. Mr. Schwar announced he will be meeting with the fire chief to review the long term budget tomorrow morning at 9:30 and then will be meeting with Sam Karish at 10:30am regarding the cell tower leasing lump sum purchase offer. Discussions ensued regarding the Mosquito Commission getting the key to the lock on pool and the key authorization policy he went over with the DPW Supervisor last week. Mr. Schwar stated that he still wants to know what a third DPW worker is going to do and that he cannot vote to put it in budget until he knows this. He explained that he misunderstood why it would be easier to keep it in the budget, as was stated in a budget meeting, and until he does he will abstain from approving. Councilman M. Schwar requested ten minutes in executive session for shared services, ten minutes for contractual regarding Open Space, and ten minutes for personnel regarding the DPW. Councilman Rooks asked about the policy regarding handing keys out and Councilman M. Schwar explained that the Clerk should have a record of signatures once keys are issued.

In closing, Councilman Schwar approved bills, salaries and wages for his department.

Health and Welfare, Councilman M. Rooks: Councilman Rooks reported on the recent garbage pick-up issue stating when he called Waste Management they said they had some sort of a vehicle issue that day. Councilman Rooks also inquired with Waste Management about why some of the garbage residents are putting out is not being taken and that they would submit to him a list of what can and cannot be put out for curbside pick-up with the regular trash yet he still has not received a response from them. Councilman Rooks announced, starting in May, the recycling area will be open Tuesdays from 12pm-7pm in addition to the Saturday 10am-4pm hours. Councilman Rooks announced the townwide clean-up dates will be June 13th & 14th. Curbside for seniors is on 13th and seniors can leave address & name with the Clerk to be put on the list. The clean-up contract is out for bid at this time and the procedure for dropping off trash for clean-up day will be just like the previous year. Councilman Rooks requested ten minutes in executive session for potential litigation and ten for contractual regarding the recycling area. Councilman Seiss stated a garbage truck is going up the alley way to pick up garbage had a complaint that trucks are tearing up alley which Councilman Rooks indicated he will follow up on with them when he speaks with them.

In closing, Councilman Rooks approved all bills, salaries and wages for his department.

Public Property, Councilwoman Carol Schwar: Councilwoman C. Schwar reported on the long list of items the DPW has been getting done such as painting the library bench and mulch for courtyard. Councilwoman C. Schwar stated she has two estimates for roof over Benke bleachers but she has not yet reviewed them. Councilwoman C. Schwar gave updates about the repairs at Marino, the salt shed canopy repairs, the HVAC system, the salt shed cameras, extra dirt added to the quarry road by Penn Bower, and playground upgrades & repairs. Councilwoman C. Schwar gave an update regarding the Industrial Park signs explaining an extra charge of \$100 for any special design requests and that JHM Signs continues to work on the project. The businesses will be listed in alphabetical order on the signs for simplicity purposes. Councilwoman C. Schwar requested ten minutes in executive session for contractual regarding the quarry road and discussed an upcoming inventory of computer equipment in basement for the county recycling program. Councilwoman C. Schwar discussed the email about speeding on Seventh Avenue and stated that once a meeting is scheduled, residents should be specially noticed for it. Discussions ensued regarding the installation of an underground wire at Circle Field and Councilwoman C. Schwar approved all bills, salaries, and wages for her department.
