Mike Savary, Park Ave., inquired about water services being cut off on 519. Engineer, Frank Seney stated he will speak with Stephanie regarding this. Mr. Savary inquired about change orders and Durnin possibly getting paid extra and tax payers shouldn't pay for that.

John Ross, Frey Engineering, responded that the original jetting video was off by 6 feet.

### § 403-21Water rates; turn-on and turn-off procedures.

<u>A.</u>

The rates for water services per quarter shall be as follows:

For residential, commercial, industrial, and multi-use building usage:

[Amended 3-22-2005 by Ord. No. 05-05]

<u>(a)</u>

A minimum service fee of \$80.00 per quarter per unit for residential and multi-use building(s); and minimum service fee of \$80.00 per quarter per unit for commercial and industrial.

<u>(b)</u>

A charge additionally of \$0.0038 per gallon of water used and metered per unit.

(c)

In a residential unit where there is no water meter, charges shall be equal to the average residential usage within the Borough during the previous quarter as determined by the Alpha Department of Public Works.

(2)

Multiple-use building. Each physical unit within a multiple-use building shall be \$80, plus \$0.0038 per gallon of water used and metered.

(3)

Specific rates:

<u>(a)</u>

Water for fire protection system: \$500 per annum, plus the commercial rate for any water used.

[Amended 5-13-1997 by Ord. No. 97-8]

<u>(b)</u>

Cemeteries: \$45 per annum. If metered, the same rate as residential.

[Amended 5-13-1997 by Ord. No. 97-8]

(c)

Churches: same as residential rate.

[Amended 5-13-1997 by Ord. No. 97-8]

<u>(d)</u>

Schools: same as residential rate.

[Amended 5-13-1997 by Ord. No. 97-8]

<u>(e)</u>

Fire hydrant service to other communities: \$125 per hydrant per annum.

<u>B.</u>

Miscellaneous fees. Fees for miscellaneous services shall be as follows:

Turn-off charge: \$50.

(2)

Turn-on charge: \$50.

(3)

Water for building construction, minimum flat rate charge: \$100.

<u>(4)</u>

Repairs of pipes or appurtenances by Department of Public Works or outside contractors: actual cost plus equipment rental. Payroll costs for municipal employees shall be at 1.50 times actual payroll rate.

Testing of meter for accuracy, as requested by the consumer, if it's found to be accurate: \$25.

<u>(6)</u>

Services of Department of Public Works employees: 1.50 times the actual hourly rate per hour for all Department of Public Works employees involved.

<u>C.</u>

In special cases not contemplated in the above schedule of rates or not clearly defined therein, the Borough Council is hereby authorized to establish special rates by resolution, under such schedule or formula as the Council may deem advisable, and the Council may make contracts with such special users as the special circumstances may require.

<u>D.</u>

No abatement of water rent will be allowed by reason of disuse or diminished use or vacant premises. All consumers who wish to discontinue service must notify the Director in writing. The service line will then be shut off at the curb. When notified that the service is desired, the water will be turned on again at the curb by the Department of Public Works upon payment of the fees as set forth in § 403-21B to the Borough of Alpha.

### NOW, THEREFORE, BE IT ORDAINED by the Council of the Borough of Alpha in the County of

Warren and State of New Jersey that "Section 243, Water and Sewer, Article III, Sewer Rents" be amended, in part,

and supplemented as follows:

### Article III:Sewer Rents

[Adopted 12-23-1969 by Ord. No. 204 (Ch. 97, Art. II of the 1974 Code)]

### § 403-38 Designation of sewers as self-liquidating utility.

The sanitary sewers of the Borough of Alpha shall be operated as a self-liquidating utility, and charges for such service shall be imposed upon users thereof. The revenue derived therefrom shall be dedicated to the purposes of such service as a self-liquidating utility.

### § 403-39 Definitions.

As used in this article, the following terms shall have the meanings indicated:

### BASIC AMOUNT

The initial charge imposed for sewer services in a multiple-use building. Said charge shall be computed by multiplying the total number of units contained in a multiple-use building by \$40 per quarter.

[Added 3-27-1979 by Ord. No. 295; amended 12-13-1988 by Ord. No. 416]

### COMMERCIAL ESTABLISHMENT

Any room, group of rooms, building or other enclosure used for the sale or distribution of any produce, commodity, article or service and specifically shall include churches, chapels, club rooms, firehouses, professional offices, banks, schools or any other room, group of rooms, building or enclosure not included in the definition of residential unit or industrial establishment.

## INDUSTRIAL ESTABLISHMENT

Any room, group of rooms, building or other enclosure used for the manufacturing, processing, cleaning, laundering or assembling of any product, commodity or article.

### MULTIPLE-USE BUILDING

Any building containing a room or group of rooms used for more than one purpose as defined in this section (e.g., a building containing a residential area and a commercial area).

[Added 3-27-1979 by Ord. No. 295]

### **RESIDENTIAL UNIT**

Any room, group of rooms, house trailer or other enclosure occupied or intended for occupancy as separate living quarters by a family or other group of persons living together or by persons living alone.

#### § 403-40 Sewer service charges.

[Amended 9-22-1970 by Ord. No. 207; 3-27-1979 by Ord. No. 295; 2-8-1983 by Ord. No. 356; 1-27-1987 byOrd. No. 392; 12-13-1988 by Ord. No. 416; 4-23-1991 by Ord. No. 451; 5-11-1993 by Ord. No. 482]

The following charges shall be imposed upon users of such service as follows:

## <u>A.</u>

Residential, Commercial, Industrial, Multiple-use Buildings.

The quarterly charge for sewer service shall be a minimum of \$40.00 for each unit for residential and multi-use building(s) and a charge additionally of \$0.0090 per gallon of water used and metered.

The quarterly charge for sewer service shall be a minimum of \$40.00 for each unit for commercial and industrial and a charge additionally of \$0.0090 per gallon of water used and metered.

For each and every building having a multiple use, there shall be a basic quarterly charge for sewer service of \$40.00 for each unit contained in such building receiving sewer service. For example, if a multiple-use building contains two residential units and one commercial unit, the basic quarterly charge shall be \$120.00 or \$40.00 multiplied by three.

## <u>B.</u>

Any person owning a building which has been classified as a multiple-use may appeal such classification to the Zoning Officer at any time by proving to said Officer, in his sole discretion, that one or more units contained in said building and comprising a portion of the multiple-use classification receive no sewer service whatever and therefore should not be counted as a unit or included within the classification.

<u>C.</u>

Charges to newly connected units. Any charges to units newly connected to the sewer system shall commence at the beginning of any year in which any such unit connects to the Alpha Borough sanitary sewer system. The quarterly charge for sewer service shall be as stated above for each unit.

### § 403-41 Future changes in service charges authorized.

The Borough Council shall have the authority to adopt a resolution, if necessary, to increase or decrease the aforesaid quarterly sewer service charges for residential, commercial and industrial users, along with multiple-use buildings, and may compute the sewer service charges on the basis of water usage as determined by actual water meter reading or by minimum and maximum quarterly sewerage service charges.

§ 403-42 Billings; collection of unpaid charges.

# <u>A.</u>

All sewer rental billings are on a quarterly charge basis.

# <u>B.</u>

In the event of nonpayment of all or any part of the service or rental charge herein prescribed and provided for as due, such service charge or rentals shall bear interest at the rate equal to that which is set by the Borough of Alpha for delinquent municipal taxes. Unpaid service or rental charges shall be a lien on real property and subject to collection and enforcement of such liens as are provided by law.
