Mayor, Craig S. Dunwell called the Regular Meeting of the Common Council of the Borough of Alpha to order at 7:00 P.M. on Monday, January 25, 2016.

Mayor Dunwell announced that adequate notice of the meeting was given to the Star Gazette and posted on the bulletin board in the Clerk's office satisfying the requirements of the Open Public Meeting Act:

NOTICE

Pursuant to the provisions of the Open Public Meetings Act, adequate notice of this meeting has been given. On January 1, 2016, the Municipal Clerk delivered to the Star Gazette and posted on the bulletin board in the Municipal Clerk's office a notice containing the date, time, and place of this meeting of the Borough Council. Also said notice has been mailed to persons requesting the same.

Mayor Dunwell led prayer and the salute to the flag.

Roll Call: Present; Councilwoman Grossman, Councilman Pettinelli, Councilman Preiss, Councilwoman Ronan, Councilman Schwar and Councilman Seiss. Also present, Attorney Christopher Troxell and Clerk, Laurie Barton.

Public Presentation – JCP&L

A representative from JCP&L spoke before the Mayor and Council summarizing the efforts of those involved with preparing for winter storm Jonas.

The local JCP&L office will be working with the local OEM coordinators with regards to potential storms and preparedness. The shore area was hit pretty hard. 129,000 were out of power and there was loss of life due to the storm. Spoke about proactive notifications and communications and how they will help with residents. They will be sending out notifications in the future depending on where the storm is. A local coordinator will be involved. The Alpha Fire House is working on getting a grant to help with the generator. Organizing education seminars to organizations like senior groups and rotary clubs to educate them on the storm process. Mayor Dunwell stated an applicant came before the LUB and wanted five containers of batteries that will pull power off the grid for frequency control. The Representative said he was not aware of specific project and if they connect to the grid they need to contact the engineering department with JCP&L. The tree trimming program has been enhanced and they are doing

more based on the permission from municipalities and homeowners. They are aggressively working on tree trimming.

Public Comment:

Ann Hart, 789 Sigsbee Ave., spoke on her own behalf regarding her appointment made last November from Mayor Hanics. Ms. Hart spoke in length regarding her appointment qualifications and the process of appointees to the library board. Stated she was appointed and/or approved for a three year term. Asked if that was valid and if she was still a member of the library board.

Discussions ensued with Attorney Troxell giving a legal opinion on the appointment that was made with it not being in accordance to New Jersey Statute. Attorney Troxell explained the process of the Mayor bringing names forward to Council for consideration. Stated the three year appointment term is not legal. Those terms ended December 31, 2015.

Councilwoman Ronan stated there should have been discussions on who would fill that open position. Those three people would need to come forward and express their credentials and decision could be made on that motion. Attorney Troxell continued explaining how the Mayor puts the names forward.

Ann Hart stated she did think they were filling the void, at that meeting expressed being on board for a new term. She still wants to be considered to be on the board. Discussions of legality of appointment, terms, and vacated positions ensued.

Ann Hart brought up bylaws and stated a nominating committee should be created. She feels like she was kept in the dark and a courtesy call should have been made. She asked what the criteria was that these other people hold making them much better that she couldn't even be considered. She feels she is a valuable part of the community and still wants to be part of the library board. Lengthy discussions ensued regarding the legality of the appointments and the qualifications of the two that were appointed by Mayor Dunwell.

Councilwoman Ronan made a motion stating in accordance with Roberts Rules, rescind the appointments pending further investigation and review of the additional people that are interested in taking these positions. Councilman Seiss seconded that motion. Councilman Seiss stated he feels the system is flawed, he questions it. Mayor Dunwell Explained the December 11th meeting and Executive session regarding personnel and going over appointments.

Councilman Schwar stated that in three months from now a new library board member could come forward to get on the board and we could go through this again. .

Councilman Pettinelli asked where the consistency is. Lengthy discussion ensued questioning the appointments. Roll call: Ayes: Pettinelli, Preiss, Ronan and Seiss. Nays: Grossman and Schwar. Attorney Troxell stated that he didn't this was a proper motion or legal.

Dave Miers – Sampson Ave. - stated this body is obligated to do a do-over. Bylaws of the library state the terms are three year terms. These two new members appointment is for five years. Attorney Troxell believes it is five years. Library Board can be up to five years. Bylaws are three year terms. To come up here is a violation of the bylaws, terms are three years based upon law. Attorney Troxell quoted paragraph 40:54-9 NJSA.

June Heyer, Vice President, Library Board said they did not inform anyone on the Library Board there was an error. Everyone on the Library Board was caught by surprise by the two new members. Mayor Hanics always did it in the past, we always heard, we interviewed them with the Mayor present, he gave the Library Board an opportunity to work with him. Should be a joint effort so we know who is coming in and who is most qualified to come in. We always had Council represented at our meeting. We were not informed, it was done behind our backs.

Sue Smeal, President, and Library Board stated at the meeting in November they presented their resume. Very interested in making library better. When I was at the library, never got an inkling this was going down. As a courtesy as President of the Library Board, communication should be extended. Mr. Trent doesn't even have a library card and he didn't even know where the library was.

Louis Cartabona, 5th Avenue – Suggested listening to the people who had a real interest, possibly look at town ordinance and expand board from five to seven members. It's my goal to work with the library board. It's hard to find people to sit on the board. Not sure if the law states a minimum of five, should expand and appoint all of us.

Ann Hart – Stated the bylaws supersede the State. That is her understanding. Board of trustees consists of seven members as follows; president, vice president, secretary, school, admin, Mayor, and two trustees. Seven total. Attorney Troxell stated we cannot infringe upon a State statute. Who runs the library and who doesn't? Library board runs the library, that's how it operates.

Millard Rooks, Vulcanite Ave. – Said if we can't have a vote to remove them, why did we just have one? In the future, don't haphazardly go throwing votes out, makes you look foolish. Slow down and make sure we are doing things properly.

Leo Pursell, High Street – stated he sat up there for 13 years, we never could use funds. The Library Board brought up a list of board members, we appointed them to that board. When their term ran out, why weren't they approached? It's a voluntary job, they are all citizens, and they should have been approached first.

Dave Miers, Sampson Ave., stated to Mayor Dunwell that it's unfair and is not characterizing the situation fairly. Implying that what we did has been illegal, you called the newspaper. We've been going through this process and have had attorneys and auditors. Everything we have been doing is legal from State Library Board. Mayor Dunwell stated that the statute is clear, surplus in excess of prior year budget is to be returned to the governing body, anything above 20% operating budget. Issue is that there is a law; we have to comply with the law.

Debra Miers, Sampson Ave. –. We don't have much for the children. That library offers the littlest to the oldest something. I will hold you to protecting the library. I'll be here to defend the library. Mrs. Miers stated that she will hold each member of Council to that. Do not mess with that library. Bring it up to where it should be, get good legal counsel.

Leo Pursell, High Street - stated that if the issue is that the law was passed, we have an obligation to abide with that.

Sharon Decker, Sigsbee Ave. - asked where you are going to get the money from.

June Heyer – stated her concern on legality of the vote. Ms. Heyer stated that she hopes the appointments are for the good of the library board and not with the money in mind. Issue here has nothing to do with money, it's with appointments.

Councilwoman Ronan stated a potential solution offered is the board being expanded. I move to do that. Attorney Troxell said would have to look at statute, not sure if Mayor's call or Council's call. Mr. Cartabona said if expanding the board it should be done by ordinance.

Ann Hart – Asked when the advisement will be completed. Will I be considered for the board? How will I be notified? I'm not sure what is going on, want to know what happened with the vote and who is on the board. Mayor explained the attorney will look into the law and the motion.

Dave Miers – Request or recommendation that in the future moving forward, that whenever decisions are being made regarding the library, as Mayor making decisions should be in concert with the president of the library board.

Sharon Decker – Stated she received three notifications to move her car on Sigsbee to move it off of Sigsbee and onto Argyle. Can't get out of Argyle. Had a terrible time getting out, terrible time getting back in, got caught on corners.

Councilman Preiss said this was a tremendous storm, our three DPW guys started plowing Friday evening through into Saturday night, 9 or 10 pm. The three guys did the work of five. Ms. Decker suggested having the guys out there earlier. That alley has always been an issue.

Department Reports:

Administration, Councilman Peter Pettinelli: Computers are running and waiting for update for Code Enforcement Officer and Clerk. The 2015 Meeting Minutes will be done any day now. Councilman Pettinelli reported that he is impressed with Greenwich's website. A

\$2,500 fee for reconstruction of our website. Councilman Pettinelli stating he is looking around with the idea of a new website. Councilman Pettinelli reported that the Clerk is still missing key from former Councilman Cartabona, key and a codebook.

In closing, Councilman Pettinelli approves all bills, salaries, and wages for his department.

Finance, Councilman Michael Schwar: Councilman Schwar reported that he sat and figured out budget numbers, and will get that to CFO to put in the state format. Need to do additional work with salaries, approve increases. Councilman Schwar stated he will be in tomorrow with the Finance Clerk and Thursday with the CFO. Health and Welfare, Councilwoman Kathleen Ronan: Councilwoman Ronan reported that she heard from Vince Catalli, the ACO and there were no animal calls. Had a discussion with him at a meeting with Mayor Ellis regarding ACO position. There's going to be some negotiations with a shared service. Between the two towns everyone is on board, details to be determined. Attorneys will look through. Mayor Dunwell asked where we stand with the dumpster issue with solid waste hauler. Councilwoman Ronan said she was not sure yet. Attorney Troxell will speak about this in executive session.

In closing, Councilwoman Ronan approved all bills, salaries, and wages for her department.

Public Property, Councilwoman Tracy Grossman: Councilwoman Grossman reported that the ice rink is filled but is covered in snow, and could use help to clear the rink. Councilman Seiss said he noticed that a lot of people are sledding, maybe we can put an area at the park coming off the hill. Councilwoman Grossman said she will look into that. Councilman Schwar advised Councilwoman Grossman to call Phillipsburg because they did something for sledding at Walter's Park. They have signs up now that they can't sled.

In closing, Councilwoman Grossman approved all bills, salaries, and wages for her department.

Public Safety, Councilman Thomas Seiss: Councilman Seiss reported that he was in constant contacted with the Emergency Management Coordinator and Police with regards to the snow storm to coordinate. Councilman Seiss reported that Mr. Stagg did a great job in coordinating a meeting everyone did a great job. No bills or salaries at this point to approve.

Public Works, Councilman Jack Preiss: Councilman Preiss reported that the DPW did an outstanding job. There are still some minor issues of snow. Charlie and crew did a great job.

In closing, Councilman Preiss approved all bills, salaries, and wages for his department.

Professional Reports:

Mayor, Craig Dunwell: Mayor Dunwell commended the DPW: Charlie, Pete, and Mike, and the Fire Company for clearing out the hydrants. The emergency management, and police did an outstanding job. Code red did a good job. Will take a few more days for alleys. Anyone with special needs bring to our attention. Requested five minutes executive session for personnel, Code Enforcement Officer and 15 minutes Contractual, Open Space.

Fire Department, Sean McDyer: Had four crews out clearing fire hydrants. Thanked borough for use of the backhoe. Cancelled their roast beef dinner. Open invitation for February 27th, annual banquet. Not sure what ticket prices will be yet.

Attorney, Christopher Troxell: Met with Code Enforcement Officer, Tom Fey. He made some progress and will continue to work on things altering our Ordinances, to address dilapidated properties. Attorney Troxell requested five minutes contractual for garbage, 10 minutes contractual for emergency, and five minutes litigation for finance. Jim Hill put together what occurred with the force main break deeming it an emergency.

After executive session will be two resolutions approving payment to Frey Engineering appropriating payment to contractor. Mayor Dunwell thanked Mr. Hill and local contractor who worked on the break.

Engineer, Frank Seney: Mr. Seney gave a summary of the reported that was distributed to Mayor and Council regarding ongoing projects and grants.

Sewer Engineer, Jim Hill: Mr. Hill gave the pump station communication update and summarized his monthly report.

CFO, Charles Daniel: Mr. Daniel reported that it is tax time. He is making sure they are sending out to the right vendors the 1099 miscellaneous income forms. Looking into number of

funds NJ Cash Management placed there a long time ago. Found out we have multiple funds there. What's in them will be moved over to PNC bank. Need to do a completed authorization to put in his name.

Clerk, Laurie Barton: Mrs. Barton provided an update on meeting minutes and also, updated on animal and mercantile licensing.

Recycling Coordinator, Tom Fey: Received some reports. Mr. Fey stated he will be making his yearly visit to businesses to get their recycling reports.

Code Enforcement Officer, Tom Fey: Code book – prepared a summary of when he took over late 2014 and late 2015. Will forward to director, assistant director, and the Mayor. We met on two properties with the Borough, 631 Dewey and 537 Alpha. Emailed Attorney Troxell to bring Council up to date. Contacted by Susan Olson in reference to 537 Alpha Street. She wanted a letter from me stating what the offenses were. Emailed her a complaint notice, see where it goes for Alpha St. Attorney Troxell took it as good news. Mr. Fey expressed his concerns over rental properties; people move out and they leave trash on the curb.

Library Board, Sue Smeal: Ms. Smeal reported that on February 10th at 5:30 a presentation by Jeff Finegan who is an expert on George Washington will be given. Carla Roselle will be doing Valentine's Day crafts on February 12th.

Mayor Dunwell stated at this time he would like to make the appointment of Kevin Duddy as Fire Inspector. Councilman Seiss made a motion to approve, seconded by Councilwoman Grossman, all were in favor.

Second Public Comment:

Sue Smeal – Sigsbee Ave. – asked about curbing, said it was last done 20 years ago at her property. Snow plow has knocked down the curbing. If any curbing can be done it would be great. It doesn't exist anymore. Ms. Smeal also thanked the Clerk for explaining the minutes,

Louis Cartabona – Fifth Avenue – Addressing landlord issue. Landlords run a business. Strongly address and amend the borough code and make landlords register. They can assist the Code Enforcement Officer. Inquiries about school, changes of school. Any up to date report? The public has the right to know of any update of water sewer billing. Revisit rate structure. Has there been any sale exchange of 1992 fire truck pumper?

Pat Fey – East Boulevard – inquired about if the plowing is done by the DPW and added that it is not done and more needs to be plowed.

Tom Fey – East Boulevard – How do we know everyone gets code red calls? Get list from landlords. Why not do sidewalks too along with the curb as well? Drainage on Vulcanite side for years. Hope problem on Olive Street gets fixed quickly with a grant or something.

Louis Cartabona – Fifth Avenue – inquired about newsletter committee and possibly approach Print Plus to get one out.

Steve Knoll – Dewey Avenue –stated his concerns about the 2011 money coming back to the municipality. Mr. Knoll stated he personally feels slighted and being trumped by a resident of 17 years and no library card.
