Mayor Dunwell called the Meeting of the Common Council of the Borough of

Alpha to order at 7:00 p.m. on June 28, 2016

Mayor Dunwell announced that adequate notice of the meeting was given and posted on the bulletin board in the Clerk's office satisfying the requirements of the Open Public Meeting Act:

NOTICE

Pursuant to the provisions of the Open Public Meetings Act, adequate notice of this meeting has been given. On January 1, 2016, the Municipal Clerk delivered to the Star Gazette/Express-Times and posted on the bulletin board in the Municipal Clerk's office a notice containing the date, time, and place of this meeting of the Borough Council. Also said notice has been mailed to persons requesting the same.

Mayor Dunwell led prayer and the salute to the flag.

Roll Call: Present; Councilwoman Grossman, Councilman Pettinelli, Councilman Preiss, Councilman Schwar and Councilman Seiss. Absent; Councilwoman Ronan. Also present, Attorney Christopher Troxell and Deputy Clerk, Amy Sharpe.

Presentation – Mr. Dan Cullen – Alpha School Principal

Mr. Cullen spoke about the Safe Routes to School project and is looking forward to making a collaborative effort between the School and the Borough. He stated the PTO is offering to put a bike rack at the school to allow kids to ride their bikes to school. He is asking Council to begin conversations regarding this when discussing Safe Routes to School. The school is also looking to making it part of the Physical Education curriculum. Mr. Cullen has identified needs to have this put into place and provided a hand out to the Mayor and Council members. Councilman Schwar stated there is grant money available. Mr. Cullen stated it would be beneficial to apply jointly to show that we are partnering. Mayor Dunwell stated tying bikes into the Safe Routes to School is interesting and we have until next June to get this together for the application deadline for the following year. Resident, Bill Morris, asked if they would provide a course at the school on the safety of riding a bike to school. Mr. Cullen is looking to do so as part of this initiative.

Mayor Dunwell – Water issue over the weekend

Mayor Dunwell stated that on Sunday June 26th there was an issue with the wells at the Frace Street plant. DPW checked these and the Ph was too high in the water going out into the system. They stopped the well. Fire hydrants were flushed and re-ran water back into the system. Ph is not a health risk, it just causes a color change and taste in the water. DEP did not come out as they were satisfied with the course of action taken by the Borough and noted the issue. The treatment plant for the west side will remain shut down until the Ph is controlled. Resident, Joey Fiore, asked if the Borough uses a water softener and Stephanie of R&V told him yes. Mayor Dunwell stated the softener causes the Ph to drop. Once softener is up and running it reduces hard water and stains. Councilwoman Grossman asked how long this will be down. Stephanie stated about a month.

Public Comment:

Joey Fiore, 1110 Morris Street – asked what came of cleaning up the two gas stations. Mayor Dunwell stated the Code Enforcement Officer was supposed to report in May and hasn't done so. Councilman Pettinelli stated he has concerns with the Code Enforcement Officer and will be speaking with him on Thursday. He was not aware he wouldn't be at tonight's meeting, hasn't reported in weeks.

Bill Morris, 537 Alpha Street – said big trucks going to BBM unloading in middle of the street. Stasak junk yard is getting bigger. Mayor Dunwell stated they were cited, in court on Wednesday, and fined \$200. Councilman Pettinelli witnessed a truck unloading there at midnight. Mayor said he was told by Mr. Duddy they were in construction phase, will be brought to him again.

Mike D'Angelo (AYAA), 1731 Springtown Road – issue with baseball damaging soccer goals, not paying for damages, season will be starting and going unnoticed.

Chris McGee, 1218 Springtown Road inquired about sidewalks for the stretch of his road, very heavy foot traffic. He was looking at blacktop/pavement instead of concrete. Part is 519, part is Lee Ave.

Joey Fiore, 1110 Morris Street – asked about the pool.

ORDINANCE 2016-10

BOND ORDINANCE PROVIDING AN APPROPRIATION OF \$200,000 FOR IMPROVEMENTS FOR THE SEWER UTILITY IN AND BY THE BOROUGH OF ALPHA, IN THE COUNTY OF WARREN, NEW JERSEY AND AUTHORIZING THE ISSUANCE OF 160,000 BONDS OR NOTES OF THE BOROUGH FOR FINANCING PART OF THE APPROPRIATION. BE IT ORDAINED, BY THE BOROUGH COUNCIL OF THE BOROUGH OF ALPHA, IN THE COUNTY OF WARREN, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

SECTION 1:

The improvement described in Section 3 of this Bond Ordinance (the "Improvement") is hereby authorized to be undertaken by the Borough of Alpha, in the County of Warren, New Jersey (the "Borough") as a general improvement. For the said Improvement there is hereby appropriated the amount of \$200,000, such sum includes the sum of \$40,000 as the down payment (the "Down Payment") required by the Local Bond Law of the State of New Jersey, constituting Chapter 2 of Title 40A of the New Jersey Statutes, as amended and supplemented (the "Local Bond Law"). The Down Payment is now available by virtue of provision in one or more previously adopted budgets for down payments for capital improvement purposes.

SECTION 2:

In order to finance the additional cost of the Improvement not covered by application of the Down Payment, negotiable bonds of the Borough are hereby authorized to be issued in the principal amount of \$160,000 pursuant to the provisions of the Local Bond Law (the "Bonds"). In anticipation of the issuance of the Borough are hereby authorized to be issued in the principal amount notes of the Borough are hereby authorized to be issued in the principal amount not exceeding \$160,000 pursuant to the provisions of the Local Bond Law (the "Bonds").

SECTION 3:

(a) The Improvements hereby authorized and the purposes for the financing of which said obligations are to be issued is for improvements to the Sewer utility including but not limited to, improvements to the sewer collection system, including the improvements to the sewer metering station and sewer pump station, and including all work and materials necessary therefor and incidental thereto.

(b) The estimated maximum amount of Bonds or Notes to be issued for the purpose of financing a portion of the cost of the Improvement is \$160,000.

(c) The estimated cost of the Improvement is \$200,000 which amount represents the initial appropriation made by the Borough.

SECTION 4:

All Bond Anticipation Notes issued hereunder shall mature at such times as may be determined by the municipal finance officer of the Borough (the "Chief Financial Officer"); provided that no Note shall mature later than one year from its date. The Notes shall bear interest at such rate or rates and be in such form as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with Notes issued pursuant to this ordinance, and the signature of the Chief Financial Officer upon the Notes shall be conclusive evidence as to all such determinations. All Notes issued hereunder may be renewed from time to time subject to the provisions of Section 8(a) of the Local Bond Law. The Chief Financial Officer is hereby authorized to sell part or all of the Notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the Borough Council of the Borough at the meeting next succeeding the date when any sale or delivery of the Notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the Notes sold, the price obtained and the name of the purchaser.

SECTION 5:

The capital budget of the Borough is hereby amended to conform with the provisions of this Ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey is on file with the Borough Municipal Clerk and is available for public inspection.

SECTION 6:

The following additional matters are hereby determined, declared, recited and stated:

(a) The Improvement described in Section 3 of this Bond Ordinance is not a current expense, and is a capital improvement or property that the Borough may lawfully make or acquire as general improvements, and no part of the cost thereof has been or shall be specially assessed on property specially benefited thereby.

(b) The period of usefulness of the Improvement, within the limitations of the Local Bond Law, taking into consideration the respective amounts of all obligations authorized for such purpose, according to the reasonable life thereof computed from the date of the Bonds authorized by this Bond Ordinance, is 15 years.

(c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Borough Municipal Clerk and a complete executed duplicate thereof has been filed in the office of the Director, Division of Local Government Services, Department of Community Affairs, State of New Jersey. Such statement shows that the gross debt of the Borough, as defined in the Local Bond Law, is increased by the authorization of the Bonds and Notes provided in this Bond Ordinance by \$160,000 and the obligations authorized herein will be within all debt limitations prescribed by the Local Bond Law.

(d) An aggregate amount not exceeding \$65,000 for items of expense listed in and permitted under Section 20 of the Local Bond Law is included in the estimated cost of the Improvements, as indicated herein.

(e) This bond ordinance authorizes obligations of the Borough solely for a purpose described in N.J.S.A. 40A:2-7(h). The obligations authorized herein are to be issued for a purpose that is deemed to be self-liquidating pursuant to N.J.S.A. 40A:2-47(a) and are deductible from gross debt pursuant to N.J.S.A 40A:2-44(c).

SECTION 7:

Any funds or grant monies received for the purpose described in Section 3 of this Ordinance shall be used for financing said Improvement by application thereof either to direct payment of the cost of said Improvement or to the payment or reduction of the authorization of the obligations of the Borough authorized therefor by this Bond Ordinance. Any such funds received may, and all such funds so received which are not required for direct payment of the cost of said Improvement shall, be held and applied by the Borough as funds applicable only to the payment of obligations of the Borough authorized by this Bond Ordinance.

SECTION 8:

The full faith and credit of the Borough are hereby pledged to the punctual payment of the principal of and interest on the obligations authorized by this Bond Ordinance. The obligations shall be direct, unlimited obligations of the Borough, and the Borough shall be obligated to levy ad valorem taxes upon all the taxable property within the Borough for the payment of the obligations and the interest thereon without limitation of rate or amount.

SECTION 9:

This Bond Ordinance constitutes a declaration of official intent under Treasury Regulation Section 1.150-2. The Borough reasonably expects to pay expenditures with respect to the Improvement prior to the date that Borough incurs debt obligations under this Bond Ordinance. The Borough reasonably expects to reimburse such expenditures with the proceeds of debt to be incurred by the Borough under this Bond Ordinance. The maximum principal amount of debt expected to be issued for payment of the cost of the Improvement is \$160,000.

SECTION 10:

This Bond Ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

Department Reports:

In closing, Councilman Pettinelli approved all bills, salaries, and wages for his department.

Councilman Schwar stated he did check and the money is in there for three computers. At this time Carrie Emery and Kevin Duddy will receive one and we should get the third one now just so we have it.

Finance, Councilman Michael Schwar: Councilman Schwar reported that Kevin Liefert, will be assisting the CFO. He told us we shouldn't be certifying funds on estimates. In the future, what is there, is what we have and will certify funds as long as they are there. Mayor Dunwell reported that a deal was made with a resident regarding water shut-off. They paid then the check bounced. Mayor Dunwell feels if neighbor is sharing through a hose then both parties should be cited. Councilman Schwar will be attending a WCEDC meeting on July 2nd at 7:30 pm. He would also like to thank everyone for getting Homa Lane flooding addressed. Councilman Schwar requested five minutes executive session for contractual regarding Farmland Preservation.

In closing, Councilman Schwar approved all bills, salaries, and wages for his department.

Health & Welfare, Councilwoman Kathleen Ronan: As per Councilman Seiss, Councilwoman Ronan advised Councilman Seiss she would be absent tonight and had no report.

Public Property, Councilwoman Tracy Grossman: Councilwoman Grossman reported that Industrial Avenue has had two acres cleared and can start receiving bids. The ladies room at the park has been fixed by DPW and is now open. There will be one port-a-john being moved toward the playground. Mayor Dunwell asked if we can keep the bathrooms open. Councilwoman Grossman said she has been told there was vandalism. Councilwoman Grossman stated that herself, Mayor Dunwell, and Councilman Preiss met and discussed the audio system and moving the panic button in the old court room. Sensor lights will be placed at the pavilion and we are moving forward with Metz. There was no one else that wanted to give us an estimate. She received three estimates for power-washing the basketball courts. One was \$60 per hour, one was \$600 per day, and Pip's was \$500 and will have it done in two days. Councilwoman Grossman wanted to mention that the Borough paid an amount of \$6,232.00 for the town clean-up as a service to the residents. Movies in the park will be taking place on July 20th, August 10th, and August 31st. The cost is \$225 for each license and the screen is \$785. The cone and truck guy will also be there selling frozen ice. Movies start at 7:30 pm.

Mayor Dunwell requested to comment or have discussion regarding public property. He stated the basketball courts need to be regulation and asked Councilman Schwar how we go about doing that. Stephanie provided the improvements for water at Frace Street plant. Equipment has been ordered for redundancy project.

Sewer Engineer, Jim Hill: Mr. Hill said there was a meeting about the water pit. Spoke about the battery charger. Stated the chart provided that we are showing progress. Councilman Schwar asked if they send someone with the white oxide. How do you do the readings? Mr. Hill said he has a meter and they read it every Friday.

CFO: Charles Daniel: Mr. Daniel stated he has a new Trainer, his name is Kevin Liefert. At this time they are focused on items regarding Capital Grants and payroll. The audit has been completed by Supley & Clooney and we should receive results in two to three weeks.

Municipal Clerk, Laurie A. Barton: Deputy Clerk, Amy Sharpe read the Clerks report provided by Laurie Barton. Friendly reminder on whoever is going to the League Conference this year in November to get your registrations in as soon as possible to get the hotel of your choice. The May minutes are done and will be on the next agenda for approval.

Councilwoman Grossman filled out the purchase requisition for the Lock Doctor, not sure where that is with the CFO. Councilman Pettinelli asked about key card system so everyone can access & it's logged.

Bob Christian, 169 6th Avenue – Asked why both sides not being done on Olive Street. Mr. Christian wants curbing on south side.

Robert Gash, Stewartsville, Director of Alpha Colts/Little Liners – Came to the meeting looking for any questions or concerns regarding Phillipsburg Little Liners/Colts. Mike D'Angelo said his only issue is practice time for soccer. Use of the field from mid-July through mid-November, use of the fieldhouse.

Motion made by Councilwoman Grossman to allow Little Liners/Alpha Colts use of the field from mid-July through mid-November, seconded by Councilman Pettinelli, all were in favor.
